Companies must file their Corporation Tax Return online with HMRC. The documents which must be submitted alongside the CT600, are the accounts and Corporation Tax calculations. Companies must register with HMRC to file online and obtain a user ID and password. You may like to ask your accountant to deal with this on your behalf.
