### **Motor industry forms and fees - Queensland**

A home owner may ask (appoint) you to act as their agent to sell or negotiate the sale of their manufactured home. To do this they must sign a Selling authority (Manufactured Homes Form 9) (PDF, 146KB). Under this authority, you must not charge a fee that is more than the amount set under official regulation.
