Include at least 2 body paragraphs. A short position paper may only contain 2 body paragraphs - one for the counter-argument and one for the supportive points. However, most position papers will have 3 or 4 body paragraphs, with 2 dedicated to supportive evidence. Depending on the length of your paper, you may decide to include more.

Generally, position papers are about 300 words (one half page, single-spaced) per topic. Thus, in GA and ECOSOC Committees, the position paper for both topics is about a single-spaced page of text. Some exceptions: Topics in Security Council simulations are not pre-designated.
